Synoptic Links: Augustine on Human Nature

Ancient Greek Influences – see Plato's influence on Augustine, including important ways they depart
Knowledge of God - implications of original sin on human capacity to know about God through reasoning
Afterlife - implication of Augustine's teaching on grace and its implication on who will be saved
Theodicy - Augustine's teaching on evil as a privation
Kant - Kant's view that humans can overcome their animal instincts and use reasoning to work out right and wrong
Secularism - the views of Freud and Dawkins could be used to criticise Augustine
Gender & Society - Augustine's teaching on the role of men and women

Synoptic Links: Natural Law Theory

Conscience - explain the link between NLT and Aquinas' view of conscience: the role of synderesis and ratio, distinguishing between infallible principles and their application
Situation Ethics - contrast NLT with Situation Ethics as two distinctly Christian but different ethical approaches
Metaethics - Draw a link between naturalism (a metaethical theory) and natural law and utilitarianism (normative ethical theories) - is goodness an observable feature of natural world?
Knowledge of God - Aquinas argues that we can use reasoning (ratio) to learn about God/what is right
Sexual Ethics - the primary precept of reproduction, and its application to issues of sexual ethics
Ancient Greek Influences - Aristotle's teleological approach and his influence on Aquinas
Christian Moral Principles - Natural Law Theory as the basis of Catholic moral teaching

Synoptic Links with the Ontological Argument

Attribute of God – the question about how we define God has implications on how we understand his attributes

Mind, Body, Soul - we revisit Descartes

Synoptic links with Kant

Metaethics - though it is debatable whether Kant himself was an intuitionist, many deontologists that followed are intuitionists

Afterlife - Kant's three postulates, that we have free will, there must be an afterlife, and God must exist

Applied Ethics - application of Kantian ethics (especially the principles of universalizability and ends and not means) to euthanasia, business ethics and sexual ethics

Synoptic links with Utilitarianism

Metaethics - Draw a link between naturalism (a metaethical theory) and natural law and utilitarianism (normative ethical theories) - is goodness an observable feature of natural world?

Christian Moral Principles - Mill compared the principle of utility with the Golden Rule

Ancient Greek Influences - though outside the syllabus, can draw a link with Epicureanism

Applied Ethics - application of Kantian ethics (especially the principles of universalizability and ends and not means) to euthanasia, business ethics and sexual ethics

Synoptic links: Religious Experience

Jesus Christ - the miracles performed by Jesus Christ are examples of religious experience

Mind, Body, Soul - near-death experiences may point to life after death

Secularism - Freud's views about religion being a neurosis and infantile desire for a father figure

Pluralism and Theology - to what extent are religions phenomenal cultural constructs

Religious Language - the ineffability of God raises problems about religious language

Knowledge of God - knowledge of God can be gained directly through religious experience

Synoptic Links with Knowledge of God

Augustine on Human Nature - Augustine's view that humans are corrupted by original sin might be used to argue against Natural Theology

Cosmological/Teleological Argument - the link between Natural Theology and the arguments based on observation of the natural world

Pluralism and Theology/Afterlife - implications of natural theology and revealed theology on who can learn about God and will be saved

Jesus Christ - Barth's Theology of the Word

Secularism - Dawkins arguments against natural theology and revelation

Religious Experience - knowledge of God can be gained directly through religious experience

Synoptic Links with Metaethics

Natural Law Theory, Utilitarianism - Draw a link between naturalism (a metaethical theory) and natural law and utilitarianism (normative ethical theories) - is goodness an observable feature of natural world?

Kant - though it is debatable whether Kant himself was an intuitionist, many deontologists are intuitionists

Religious Language - A.J. Ayer on verification principle points to the meaninglessness of religious language and ethical language (emotivism)

Synoptic Links with Religious Language

Attributes of God - consider the limitations of using language and the danger of anthropomorphising God. 'Superlatives are diminutives when applied to God'. We reduce him to a superman like figure

Ontological Argument – the question about how we define God

Ancient Greek Influences - the influence of neoplatonism on apophatic theology

Jesus Christ - Application of Via Negativa to Christology e.g. The Council of Chalcedon and doctrine of hypostatic union is guarded by apophatic language.

Synoptic Links: Situation Ethics

Conscience - compare Aquinas and Fletcher's view of conscience as an act

Natural Law Theory - contrast NLT with Situation Ethics as two distinctly Christian but different ethical approaches

Metaethics - Draw a link between naturalism (a metaethical theory) and natural law and utilitarianism (normative ethical theories) - is goodness an observable feature of natural world?

Christian Moral Principles - a comparison between Fletcher's situation ethics and Tillich's ethics (link)

Jesus Christ - Jesus' teaching on agape love and whether it should be privileged over his other teachings

Synoptic Links: Moral Action

Situation Ethics - influence of Bonhoeffer on Fletcher, especially on how rules can be broken

Jesus Christ - Bonhoeffer's concept of discipleship and costly grace, following Christ's example

Liberation Theology - Bonhoeffer's emphasis on right action to overcome structure of injustice may have influenced liberation theologians

Secularism - The example of Bonhoeffer might be used to defend positive impact religion can make on an individual

Synoptic Links with Pluralism and Theology

Pluralism and Society - the views of exclusivists, inclusivists and pluralists on issues of inter-religious dialogue and conversion

Secularism - atheist criticisms against religion and whether it promotes disharmony between groups

Knowledge of God - the issue of whether knowledge of God comes exclusively through revelation

Death and afterlife - different views of heaven and hell and whether everyone will go to heaven, including the teaching of Jesus in Matthew 25

Attributes of God – God's benevolence and justice and how it relates to questions about judgement and salvation

Synoptic Links with Liberation Theology

Jesus Christ - our study of Christ as Liberator could be used to support Liberation Theology

Business Ethics - Marxist critique of capitalism and how it gives rise to exploitation and alienation

Christian Moral Action - Bonhoeffer's emphasis on right action to overcome structure of injustice may have influenced liberation theologians

Situation Ethics - Fletcher's equating love and justice is influenced by Marx

Synoptic Links with Gender and Theology

Ancient Greek Influences - Plato and Aristotle's views of women

Gender & Society - liberal feminist and radical feminist criticisms of Christianity and John Paul II's defence of Catholic teaching on the role of women

Christian Moral Principles - the bible's attitude to women and scholarly criticism against the Bible

Jesus Christ - the view of Jesus as a Servant King rather than a Davidic Messiah may support Ruether's project to reform Christianity

Religious Experience - female spirituality links to religious experience

Liberation Theology - the influence of liberation theology on feminist theology

Attributes of God - contrast the traditional view of God as 'Sky-Father' ruling over creation with Process Theology

Religious Language - to what extent is gendered language about God analogy?

Synoptic Links with Secularism

Cosmological and Teleological Argument - the fine-tuning argument may point to the compatibility between religion and science?

Knowledge of God - Dawkins arguments against natural theology and revelation

Normative Ethics - question whether Christian ethics promotes discrimination e.g. NLT and Catholic teaching on homosexuality

Religious Language - verificationism and falsificationism point to meaningless of religious language

Feminism and Society - Feminist criticisms against religion can be used to support need to separate church and state
